FAMILY AND SINGLE WOMEN'S PROGRAM: THE FAMILY SHELTER PROGRAM CAN ACCOMMODATE UP TO 11 FAMILIES AND THE SINGLE WOMEN'S PROGRAM CAN ACCOMMODATE UP TO 10 SINGLE WOMEN. IN 2020, THE CAPACITY WAS REDUCED DUE TO THE CORONAVIRUS PANDEMIC, TO PROVIDE SAFE DISTANCING, FOR THE GUESTS IN OUR CARE. THEY RECEIVE CASE MANAGEMENT, INDEPENDENT LIVING SKILLS TRAINING, PARENTING EDUCATION, COUNSELING, LINKAGES TO MEDICAL CARE, CHILD CARE & TRANSPORTATION. OVER FIFTY PERCENT OF THOSE ENTERING THE SHELTER ARE SURVIVORS OF DOMESTIC VIOLENCE. IN 2020, 17 FAMILIES (26 CHILDREN AND 19 PARENTS) AND 26 SINGLE WOMEN WERE SERVED BY THE EMERGENCY SHELTER.
